Set up is between 10:00 am on Wednesday and 10:00 am on Thursday.

Take down is not before noon on Sunday.

**You may add up to two additional employees for \$50.00/person.**

**Any employees beyond that must purchase a festival ticket for the days they are working. Thank you for supporting the festival!**

**Electricity is \$10.00/day for the booth.**

**To plug in a personal RV in addition to your booth is an extra \$10.00/day and there is a \$15.00 dumping fee if needed. Tent camping is free.**

**If you require an additional camping space directly behind your booth you must let us know at the time of your application.**
